The college has to give an undertaking that the students admitted to this course shall be paid stipend on par with the stipend being paid to the Postgraduate students of State Government Medical Institutes/Central Government Medical Institutions, in the State/Union Territory where the institution is located as required under Clause 13.3 of the Postgraduate Medical Education Regulations.
6. 


